


CUSTOMER DISTRIBUTION





CUSTOMER STATISTICS




- Competitive dialogue with 6-8 suppliers
- Important to have different platforms in the dialogue
- Award 2-4 contracts/platforms
- Parallel framework agreements
- Not divided into lots
- Non-exclusive and voluntary
- No obligations to purchase
- Free to procure the services outside the contracts

- Contracting through a central purchasing body (a "CPB", ref. EU Directive art. 37)
- 5-10 BNOK/3yrs
- Well thought-out contract framework
- Setting the standard for the public sector
- Call-offs from 6-12 months to a few weeks
- Information security and GDPR
- Governance



GROUPS OF ECONOMIC OPERATORS




- Groups of economic operators are allowed to participate
- A group of economic operators may rely on the capacity of other entities to fulfil the qualification requirements
- A group submits a joint tender
- The economic operators of the group shall be jointly and severally liable for the execution of the framework agreement, and the contract shall be signed by all partners of the group
- Note:
 - Each participant to provide: (i) ESPD, (ii) Certificate of registration, and (iii) tax certificate
 - Attachment 2: Form for groups of economic operators submitting a joint request to participate
 - Attachment 3: Declaration of commitment from entities on which the candidate relies to fulfil qualification requirements
 - May require contract between the operators prior to final tender

SUBCONTRACTORS

- Assessed critical nature of several parts of the infrastructure components
- Extremely complex contractual environment
- The use of subcontractors is allowed
- Responsible as if the supplier itself is performing
- The supplier shall be the sole contracting party
- If the supplier is not a cloud service provider, the supplier shall guarantee the cloud service providers' full attendance, cooperation and participation in the dialogue
- The Contracting Authority strongly urge the cloud service providers to participate as prime contractors
- Note:
 - Attachment 3: Declaration of commitment from entities on which the candidate relies to fulfil qualification requirements

QUALIFICATION REQUIREMENTS



- Assessment of candidates' ability to perform the contract/deliverables
- Candidates are responsible for ensuring that all requested documentation is submitted, and that all questions and requirements are answered
- Candidates who do not comply with all qualification requirements will be rejected
- Reliance on the capacities of other entities

QUALIFICATION CRITERIA/REQUIREMENTS



WHEN RELYING ON ANOTHER LEGAL ENTITY FOR FULFILLING QUALIFICATION REQUIREMENTS/CRITERIA: SUBMIT A **DECLARATION OF COMMITMENT + ESPD**

INDEPENDENT ENTITY = **DECLARATION OF COMMITMENT + ESPD** AFFILIATE = **DECLARATION OF COMMITMENT + ESPD** ANY OTHER FORM OF ENTITY (INTERCOMPANY AGREEMENT) = **DECLARATION OF COMMITMENT + ESPD**

DO NOT FORGET: DECLARATION OF COMMITMENT + ESPD

SELECTION CRITERIA



- Will limit qualified candidates to a minimum of 6 and a maximum of 8 candidates
- Only one cloud solution platform per participant


